To Recognize Friends of the Bohm as a Service Organization to Obtain a Charitable Gaming License from State of Michigan

Purpose and Finding: As the council is aware, pursuant to MCL 432.103(k), Act 382 of 1972, in order to obtain a charitable gaming license with the State of Michigan, the organization must have recognition as a “service organization” from the local municipality. Friends of the Bohm is requesting that they be recognized as a service organization. Please note, the City was previously provided with the name “Walk the Beat” for approval in resolution 2019-19, which was inaccurate. The actual organization seeking approval is Friends of the Bohm. Approval is recommended.
