WHEREAS, THERE was no levy set for the South Platte School – District 95 – General, the South Platte School – District 95 – Bond, or the South Platte School – District 95-Special Building Fund and the levy should have been set for the South Platte School – District 95 – General in the amount of 0.640000, the South Platte School – District 95 – Bond in the amount of .100000, and the South Platte School – District 95-Special Building Fund in the amount of .010000; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of Equalization of Keith County, Nebraska as follows:
