A G R E E M E N T

REGISTERED LAND SURVEYING

THIS AGREEMENT, made and entered into by and between Keith County, Nebraska, hereinafter referred to as the "County," and the State of Nebraska, Department of Roads, hereinafter referred to as the "State."

WITNESSETH:

WHEREAS, the State has plans for the improvement of Highway 61 from Highway Reference Post 99.74 to Highway Reference Post 110.24, under Project No. STP-61-2(112), and

WHEREAS, the State desires the County provide a Registered Land Surveyor to tie out land monuments prior to the above construction and tie and remonument after construction, and

WHEREAS, the County is willing to perform the above said surveying services under the following terms and conditions.

NOW THEREFORE, in consideration of these facts, the parties hereto agree as follows:

SECTION 1. The County agrees to tie out land monuments as necessary for the above named project prior to construction work beginning and to tie and remonument as necessary after construction is completed, all under the direct supervision of a Registered Land Surveyor. Said surveying work shall be completed within 60 days of receipt of written notice of the State's Project Manager. The County further agrees to file the survey with the County Surveyor and/or County Clerk, with the Survey Record Repository in the State Surveyor's Office in Lincoln and with the Deputy State Surveyor in the Roadway Design Division at the Department of Roads' Lincoln Headquarters.

SECTION 2. The State agrees to reimburse the County for the actual cost of the work described in Section 1 above, up to a maximum cost to the State for each land monument of \$100.00 to tie out and \$100.00 to remonument. The maximum cost to the State shall not exceed \$1100.00 for the tie out work and \$1100.00 for the remonument work. The County may prepare and submit a detailed billing of the work completed. All billings shall be forwarded to the State's Project Manager, or Kitty Riggins, at P.O. Box 1108 North Platte, NE. 69103. Upon the satisfactory completion of the work, the State will pay the County within thirty (30) days or the completion of an audit by the State, whichever is later.
