

2. DELIVERY, INSTALLATION & REMOVAL:

The Lessee agrees to pay the charges listed above for each unit installed or removed during the term of the contract.

3. RISK OF LOSS:

Lessee assumes the risk of loss, damage, theft or destruction from natural disaster while the equipment is in Lessee's possession.

4. OWNERSHIP/TAXES:

Ownership remains with Microfilm Imaging Systems, Inc. The Lessee is responsible to accrue, report and pay personal property tax where appropriate.

5. BILLING:

User shall pay the rent due for the equipment in installments set for in Paragraph One in advance. All charges for the month during which the equipment is installed will be prorated and commence with the date of the installation. The initial invoice will reflect the amount for the first partial billing period (if applicable) and the next full rental period. Invoice terms are net 10 days.

6. CONTRACT RENEWAL/TERMINATION:

This contract is for a minimum period as indicated above and cannot be canceled by either party except by the Lessor if any invoices are past due. However, either party may terminate upon any anniversary of the effective date by providing written notice 30 days prior to the anniversary date. If neither parties give notice of its intention to cancel, it is mutually agreed that this contract will continue for another term equal to that set forth in Paragraph One for successive like terms at rental rates in effect upon the anniversary date.

7. LIMITATIONS ON LIABILITY:

IN NO EVENT SHALL MIS BE LIABLE FOR ANY SPECIAL, INDIRECT, INCIDENTAL, CONSEQUENTIAL OR PUNITIVE DAMAGES OR FOR LOST PROFITS ARISING OUT OF OR IN CONNECTION WITH LESSEE'S USE OF THE EQUIPMENT. MIS' SOLE CUMULATIVE LIABILITY TO LESSEE AND LESSEE'S EXCLUSIVE REMEDY IS LIMITED AT THE OPTION OF THE LESSEE TO THE PAYMENT (OR ISSUANCE OF A CREDIT) IN AN AMOUNT NOT TO EXCEED SIX (6) MONTHS RENT FOR THE SPECIFIC EQUIPMENT FOR WHICH DAMAGES ARE CLAIMED.

8. MAINTENANCE:

The Lessor agrees to provide to Lessee all labor, service parts and equipment modifications the Lessor deems necessary to maintain the equipment in good order. For certain equipment, the Lessor reserves the right to replace the entire unit with new equipment or equipment of equal quality when the Lessor determines that replacement is more economical than on-site repair.

9. CONSUMABLES:

As used in this Contract, the word "Consumables" means parts or materials which are necessary for complete functioning of the equipment, but which DO NOT require installation by a service technician.


Replacement of consumables, which shall include but not be limited to drums and exposure lamps are not covered by this contract and will be charged separately.

10. GENERAL:

The termination or expiration of this contract shall not relieve Lessee of its obligation to pay any sums due hereunder. This contract shall be governed by the laws of the State of Nebraska without regard to its conflicts of laws principle.
