

GARDEN COUNTY VETERAN SERVICE OFFICER

INTERLOCAL AGREEMENT

THIS AGREEMENT made and entered into between the **COUNTY OF GARDEN, NEBRASKA**, hereinafter referred to as "**Garden**", and the **COUNTY OF KEITH, NEBRASKA**, hereinafter referred to as "**Keith**"

RECITALS

- A. The Interlocal Cooperation Act. Neb. Stat. Sec. 13-1801 et seq and 19-3801 et seq, provides that two or more public agencies may enter into agreement for the joint and cooperative exercise of powers, privileges, or authority capable of being exercised by either agency; and
- B. Garden desires to contract with Keith for services to provide Garden Veteran Services through Keith's Veteran Service Officer (Keith VA Officer); and
- C. Keith is willing to contract with the Garden to provide such services; and
- D. The parties can achieve benefits in the public's interest by having Garden and Keith enter into this agreement.

NOW, THEREFORE, in consideration of the mutual covenants herein contained, it is agreed as follows by Keith and Garden:

A. KEITH OBLIGATIONS: Keith agrees:

- a. to provide county veteran services through the services of its Veteran Service Officer;
- b. Garden County Veteran Service Board appoints the Keith VA Officer as its Veteran Services Officer;
- c. Keith VA Officer will provide 2X per month office services in Garden County;
- d. Keith VA Officer will provide all services required of the Garden County Veterans Services, including the expenditures of the Garden County Veterans Aid fund as the policy is adopted by the Garden County Veterans Service Board;
- e. Contact the Garden County Clerk for purchases of equipment and/or supplies necessary for the Garden County Veterans office;

B. GARDEN OBLIGATIONS: Garden agrees:

- a. Pay Keith \$500 per month of services (\$6000 per year);
- b. Provide office space (may be shared space), equipment, internet and phone (with forwarding capabilities) and necessary office supplies;
- c. A policy for the expenditures of Garden County Veterans Aid fund will be adopted by the Garden County Veterans Service Board;
- d. Give access to Garden County "VetraSpec" program to the Officer;
- e. Provide a small account (no more than \$500) for which Veteran Service Officer can use for emergency requests and apply for re-payment of same if reimbursable; and

- f. Veterans Service Board shall appoint the Keith County Veterans Service Officer as the Garden county Service Officer.


C. LIABILITY.

- a. The parties agree to hold each other harmless for activities the Veterans Officer is performing for the respective counties.

D. DURATION.

- a. This Agreement is effective upon signature by both parties, and shall remain in effect until either party notifies the other a thirty (30) day notice in writing to terminate this Agreement.


