

PROCEEDINGS OF THE ROSEAU COUNTY BOARD OF COMMISSIONERS

November 24, 2015

The Board of Commissioners of Roseau County, Minnesota met in regular session in the Courthouse in the City of Roseau, Minnesota on Tuesday, November 24, 2015 at 9:00 a.m.

CALL TO ORDER

The meeting was called to order at 9:00 a.m. by Board Chair Jack Swanson. The Pledge of Allegiance was recited. Commissioners present were Roger Falk, Mark Foldesi, Todd Miller, Glenda Phillipe and Jack Swanson.

APPROVAL OF AGENDA

Consideration of a Minnesota Lawful Gambling Permit was added to the Consent Agenda and a discussion on an Aquatic Invasive Species Resolution and Work Plan was added to County Board Items. A motion to approve the amended Agenda was made by Commissioner Phillipe, seconded by Commissioner Miller and carried unanimously.

CONSENT AGENDA

RESOLUTION AUTHORIZING PUBLIC AND PRIVATE SALE OF TAX-FORFEITED LANDS

BE IT RESOLVED that all parcels of tax forfeited land listed on the List of Tax-Forfeited Land # 681501 is classified as non-conservation land; that that basic sale price of each parcel on the List of Tax-Forfeited Land that is on file with the County Auditor be approved and authorization for a public and private sale of this land be granted, pursuant to M.S. 282.01; that the sale will be held by the Roseau County Auditor at 10:00 am, on December 16, 2015, at the Roseau County Courthouse Boardroom, for not less than the basic sale price; and that all sales shall be for full payment on the day of the sale.

BE IT FURTHER RESOLVED that the conditions and terms of the sale shall be described in the list contained herein and approved by the Roseau County Board of Commissioners.

RESOLUTION APPROVING REQUEST FROM GOVERNMENTAL SUBDIVISIONS TO PURCHASE TAX-FORFEITED PARCELS

WHEREAS, the City of Badger and City of Greenbush have requested to purchase parcels of tax-forfeited land located within Roseau County, and

WHEREAS, the Roseau County Board of Commissioners have reviewed and considered said requests.

NOW, THEREFORE BE IT RESOLVED that the following requests to purchase tax-forfeited lands are hereby granted:

City of Badger: Subdivisions Fifteen (15), and Sixteen (16), and the North Ten (10) feet of the West One Hundred Fifty (150) feet of Subdivision One (1), all in Auditor's Plat No 14 of the Southeast Quarter of the Northeast (SE¼ NE1/), of Section Twelve (12), in Township One Hundred Sixty-one (161) North, Range Forty-two (42) West, according to the Plat thereof on file and of record in the office of the County Recorder in and for Roseau County, Minnesota.

City of Greenbush Lots Sixteen (16) and Seventeen (17), Block 2 of Solom's Addition to the Village of West Greenbush, according to the recorded plat thereof;

Lot Ten (10) of Block Twelve (12), in the Townsite of West Greenbush, according to the plat thereof.

A motion to approve the Tax Forfeited Land Sale Parcel List (public and private), and the Terms for the Public and Private Sale of Tax Forfeited Land in Roseau County, was made by Commissioner Phillipe, seconded by Commissioner Foldesi and carried unanimously.
