

**TRANSPORTATION PERMIT TERMS AND CONDITIONS FOR  
ROSEAU COUNTY ROADS AND HIGHWAYS**

1. The applicant is responsible for complying with the terms and conditions of this permit and all other transportation laws, ordinances, and regulations. The information required on the "Application for Transportation Permit" form establishes the vehicle or combination of vehicles to be used and corresponding object or material, load, and route applicable to this permit.
2. This permit for roads and highways under the jurisdiction of Roseau County only, which includes County Roads and County State Aid Highways.
3. In accordance with Minnesota State Statute 169.825 Weight Limitations, no vehicle shall exceed the Gross Weight Schedule for any vehicle in the corresponding axle group designation without a permit. The maximum gross vehicle weight without a permit shall not exceed 73,280 pounds for any vehicle or combination of vehicles with five axles or less. The maximum gross vehicle weight without a permit shall not exceed 80,000 pounds for any vehicle or combination of vehicles with six or more axles.
4. The maximum single or dual wheel weight allowed by this permit is 9,000 pounds. The maximum axle weight allowed by this permit is 9 tons (18,000 pounds). A single axle is defined by law as including all wheels whose centers may be included within two parallel transverse vertical planes 40 inches apart.
5. Permits will not be issued during Spring Load Restriction unless under an emergency. If a permit is issued on a restricted road, the maximum axle weight allowed is as shown in the following table:

6. A permit is required for loads that exceed the maximum vehicle dimensions in accordance with Minnesota State Statutes 169.80 and 169.81. The maximum legal height is 13-feet 6-inches. The maximum legal width is 8-feet 6-inches. The maximum legal legal varies depending on vehicle as shown in the referenced statutes.
7. Loads over 16 feet wide require traffic control to be provided by a Sheriff's Patrol at a fee established by the Sheriff.
8. Permits are not authorized if load can be divided.
9. Permits are not authorized for movement on Saturdays, Sundays, holidays, or after dark.
10. Permits are not authorized for movement of loads or equipment where towing vehicles are inadequate or unsafe.
11. Permits are not authorized for movement on bridges which exceed the posted limits.
12. Permits are not authorized for movement over roads which in the opinion of the County Engineer would be damaged.
13. Permits are not valid for vehicles or operators that do not conform to requirements established by any law, ordinance, or regulation. The County is not responsible for verifying the vehicle or combination vehicle registration and licensed, weight, insurance coverage, operating condition, the vehicle operator's drivers license, or any other vehicle related criteria required by any law, ordinance, or regulation.
14. The County is not responsible for verifying the vehicle or combination vehicle axle and gross weights or the overall length, width, and height of the vehicle or combination vehicle and object or material hauled complies with this permit.
15. The applicant is responsible for the adequacy and/or condition of the vehicle or combination vehicle and any equipment required to load, secure, haul, or tow any object or material included in this permit. The applicant is responsible for any and all operations required to perform the transportation included in this permit.
16. The applicant is responsible for contacting and complying with any utility owners that may have facilities (overhead telephone and/or power lines) that would be impacted by the transportation included in this permit.
17. The applicant will defend and hold harmless Roseau County and its agents or employees in any traffic violation, civil, or criminal action resulting from the transportation authorized by this permit.
18. The applicant will assume all liability to the traveling public and for damages done to bridges, roads, or other structures. Roseau County will not be liable for any damages to mover or owner for failure of bridges or other structures to support truck and materials hauled over same. Moving contractor may have to furnish bond to cover any damages done to bridges, roads, or any other structure on roads.
