### TOWN OPERATIONS UPDATE

Pursuant to Governor Northam's most recent Executive Order, all Town of Warrenton Government buildings and offices to include the Town Hall Building, the Public Works and Utilities Facility, the Police Department Facility (Lobby), the Warrenton Aquatic and Recreation Facility (including all playgrounds and shelters located within the Parks), and the Warrenton-Fauquier Visitor Center will remain closed until June 10, 2020, or until such time as the Executive Order has been lifted by the Governor.

In doing business with Town government, residents are urged to complete transactions online, by mail or by phone. Payment of water/sewer bills, building permits and plan submittal, etc. may be paid and submitted on-line, placed in the mail or in the drop box located at Town Hall, 18 Court Street. Residents may continue to reach Town staff for questions or concerns by calling Town Hall at 347-1101. Residents may also email Town staff with questions at [staff@warrentonva.gov](mailto:staff@warrentonva.gov). Trash and recycle bags are still available for pickup or purchase, contact Town Hall to schedule the pickup.

In keeping with the Governor's limitation of no more than ten people in one location, the Town Council will hold the regularly scheduled monthly meeting virtually via Zoom Video Conference on April 14, 2020 at 7:00 p.m. This meeting will be live streamed on the Town's webpage.

EXPERIENCE
